The Awards Program has evolved over the years to respond to the emerging issues in the field of infectious diseases as well as the needs of a growing membership. RESEARCH AWARDS

Young Investigator Award

The Young Investigator Award Program was the first research award program to be offered by the Society and was developed to foster excellence in infectious diseases pharmacotherapy research among promising new investigators. This award originally provided \$2,500 to fund original research proposals by young investigators who were active members of SIDP and within five years of their terminal educational training, but is now used to recognize the work of outstanding new investigators within seven years of their terminal educational training who are active or associate SIDP members.

Infectious Diseases Pharmacotherapy Paper of the Year Award

PRACTICE AWARDS

Outstanding Clinical Practice in Infectious Diseases Pharmacotherapy Award

In 1999, the Outstanding Clinical Practice in Infectious Diseases Pharmacotherapy Award was implemented to recognize an SIDP member with exemplary skills as a clinical practitioner and educator in infectious diseases pharmacotherapy. Expertise was demonstrated by at least five years of clinical practice, maintenance of an active patient-care service responsibility, and other significant contributions, e.g. development of innovative services, documentation of benefits, and promotion of safe, effective, rationale use of antimicrobials. Funding of \$1,000 per award has been provided in the past by Rhone-Poulenc Rorer Pharmaceuticals and Aventis Pharmaceuticals.

Gita Patel Best Practice Recognition Award

In 2013, the Gita Patel Best Practice Award was established in honor of Dr. Gita Wasan Patel to recognize an SIDP member who implemented and documented the impact of an innovative or collaborative “best practice” initiative to improve care in patients with infectious diseases. These included development of novel services to deliver quality care or implementation of guidelines or pathways. Dr. Patel demonstrated passion for optimal patient care in infectious diseases despite no formal training in the field. Preference for this award was given to similar applicants in the community setting or to those who did not receive salary support dedicated to research. Formal infectious diseases training was also not required. Funding of \$1,500 per award has been provided in the past by Cubist Pharmaceuticals.

GRANT AWARDS

In collaboration with partners in industry the Society has invested heavily in research funding and advanced training of infectious disease pharmacists. Over the last 15 years SIDP has distributed over \$352,500 in grant support which has funded 42 investigators. The majority of this support has gone to funding junior investigators and has helped to kick-start many successful academic careers. The Society has also spent approximately \$665,000 to support the training of 21 infectious disease pharmacy residents. Many of these residents have gone on to develop successful clinical practices and even residency and fellowship programs of their own.
